

track were demolished with the help of heavy machinery. The drive on Thursday started with the razing of the walls of Gulbai Petrol Pump, SITE area in West district at 9am and continued until 4pm. The petrol pump administration raised a cry over the demolition and put up resistance to stop the operation. They maintained that the operation couldn't be conducted without issuance of a notification. However, the railway authorities continued to demolish encroachments and clean up the resulting debris.

Railway authorities, district administration and the area police participated in the operation.

Property and Land Deputy Director Sanaullah said that they were making fast progress in the operation. He added that of the 7km track in West district, 5km had been cleared and the remaining track would be cleared soon. Of the 46 acres of KCR land that was occupied, 36

put up resistance, however, the railway authorities continued to demolish encroachments

He said that a large area occupied by encroachments had been cleared. He added that a particular area of the petrol pump that fell within 50 feet of the KCR track had been demolished and while they faced resistance, they had managed to take control of the situation. The administration of Gulbai Petrol Pump was asked to provide documents when they resisted but they failed to show any.

Railway Assistant Executive Officer Saha Muhammad Mastoi said that the washroom at the petrol pump remains to be razed. He added that it would be done today (Friday). He said that a non-operational factory was also encroaching on KCR land which too would be razed.

Bureau (NAB) to appear in the court with preparation under any circumstances on June 25, while hearing pleas pertaining to millions rupees of corruption in police funds.

The two-member bench was hearing the appeal filed by NAB against the 10 years of imprisonment of former Assistant IG Tanveer Ahmed Tahir and acquittal of Fida Hussain in the corruption cases by the accountability court. Justice KK Agha remarked that Tahir has been sentenced and Hussain has been acquitted apparently for the same accusation.

The court told the NAB's prosecutor to appear in the court with preparation on June 25 and remarked that the court will decide after hearing the arguments.

According to NAB, the accused committed millions rupees corruption in the funds on account of petrol. The accountability court sentenced Tanveer Ahmed to 10 years of imprisonment and acquitted Fida Hussain.
